

CONTRACT OF END USER LICENSE AGREEMENT (EULA) FOR THE SOFTWARE "SHOOTERSPOOL"

(Last Update: November 2018)

This Contract of license for the final user (hereafter, "the License") is a contract between you and EVEHO INGENIERÍA SLP. This license is applicable to the use that you may make of this Software and of all the software and documents related, as well as of the updates and improvements that may substitute and complement the software and that may not be distributed with a separate license.

You have available a license for use SHOOTERSPOOL. You are not the owner of SHOOTERSPOOL. IF YOU INSTALL THE SOFTWARE, IT WILL BE UNDERSTOOD THAT YOU ACCEPT ALL THE TERMS AND CONDITIONS OF THIS LICENSE. If you do not agree with the terms of this license, neither install nor use SHOOTERSPOOL.

INFORMATION AND DEFINITION

SHOOTERSPOOL is a billiards simulator software for computers whose power relies on the experience of playing online. When you buy SHOOTERSPOOL and register as a player, you can play online with SHOOTERSPOOL software through the web platform MEMBERS.SHOOTERSPOOL.NET.

GRANT OF LICENSE AND CONDITIONS OF USE

GRANT OF LICENSE

EVEHO INGENIERÍA SLP grants you a personal limited and not exclusive license for installing and using SHOOTERSPOOL only in a personal but not commercial way, as it is stated in this license and in the attached documents. With it, the user acquires some rights subject to the compliance of the present license. It is forbidden any kind of commercial use. It is expressly forbidden sublicensing, renting, renting to own or any other type of distribution of SHOOTERSPOOL or of the rights of use. The duration of your license will start the date you begin to download, install or use in any other way SHOOTERSPOOL, and it will end the moment you throw away the Software or EVEHO INGENIERÍA SLP decides to cancel this license, whichever may happen first.

COPIES

You will be able to download SHOOTERSPOOL from an authorized source. You cannot make a copy of SHOOTERSPOOL that can be available in a network where it can be used by several people at the same time. You cannot make SHOOTERSPOOL accessible in a network that allows being downloaded by several users.

VALIDATION OF THE LICENSE

In order to validate the License, you need to have SHOOTERSPOOL and internet connection. You must have SHOOTERSPOOL installed in your computer to use this Software. You understand and accept that SHOOTERSPOOL can use information related to your system, your hardware, your means and your software, and to the use you make of SHOOTERSPOOL to validate your License rights and to get it updated.

When you buy a license of SHOOTERSPOOL you get three activations License. These activations are personal and not transferable. When activated, SHOOTERSPOOL keeps a record of the hardware on the user's computer. If the system is

changed with important hardware or software changes, SHOOTERSPOOL require a new activation.

If you spent all your activations you can buy more at the store in MEMBERS.SHOOTERSPOOL.NET.

SHOOTERSPOOL UPDATES

You accept that the Software downloads and installs additional updates, improvements and functions that will provide benefits or that will be reasonably necessary. You recognize and accept that any obligation that EVEHO INGENIERÍA SLP may have with respect to previous versions can finish as soon as an update, an improvement or an implementation of additional functions are available.

RIGHTS RESERVED AND RESTRICTIONS

You are licensed to use SHOOTERSPOOL only according to the terms of this License. SHOOTERSPOOL is not sold. Except for the terms of the License granted according to the present contract, EVEHO INGENIERÍA SLP will keep all the rights, titles and interests concerning SHOOTERSPOOL and all copyrights, trademarks and other intellectual property rights bound to the present contract.

INSTALL AND UNINSTALL

You can uninstall SHOOTERSPOOL deleting files through the "Add or Remove Programs" Control Panel. Certain empty cache folders can also remain on your computer after uninstalling the Software files. These can be deleted manually.

CONSENT FOR OBTAINING AND USING DATA

You allow EVEHO INGENIERÍA SLP to compile, use, store and transmit technical related data that identify your computer (including your IP address), your operating system, the use of SHOOTERSPOOL (including, among others, the success of the installation and uninstallation), the programs, the use of programs and hardware peripherals, that could be compiled regularly to ease the updating of programs, the content offered in a dynamic way, technical assistance related to the product and other services, included those online.

TECHNICAL REQUIREMENTS OF THE SYSTEM OF ONLINE PLAYING

In order to play and have access to the online services and functions it is required the game SHOOTERSPOOL, an internet connection, an online validation, accepting the agreement of final user licence, the last update of SHOOTERSPOOL, an user account in MEMBERS.SHOOTERSPOOL.NET and having registered the game with the series code of just one validated use. The series code registration is limited to one MEMBERS.SHOOTERSPOOL.NET account per series code. The series codes are not transferable once they have been used and they will be valid at least while the online services are available.
